## **General Scholarship Eligibility and Information**

- Each scholarship applicant must complete a Free Application for Federal Student Aid and apply for all available federal grants.
- The scholarship award amount will be determined after all other gift aid for tuition and fees has been determined and is intended to assist the student in meeting their remaining unfunded tuition and fee obligations.
- Students will be notified of their scholarship award status. Acceptance of an individual scholarship award is an agreement to the terms and conditions of that award as well as all policies governing Arizona College scholarships.
- All scholarship recipients are expected to abide by the principles of academic integrity and the Arizona College Student Code of Conduct.
- Every student's financial award package (scholarships, gift and need-based assistance) is subject to review by the Arizona College Financial Aid Office for

- compliance with federal aid regulations and the eligibility requirements for each scholarship program.
- A student's total grant, scholarship, and other gift aid may not exceed tuition, fees, room and board; if they do, the scholarship provided by Arizona College will be reduced accordingly.
- Arizona College reserves the right to adjust individual scholarship awards to account for adjustments to federal, state and scholarship dollars.
- Scholarship recipients must have at least half-time enrollment.
- Renewable awards are contingent upon maintaining the satisfactory academic progress standards found in the Arizona College catalog. Other specific renewal criteria for the specific scholarship must also be met.

## **SPECIFIC SCHOLARSHIP REQUIREMENTS**

<u>Workforce Investment Act Participant:</u> Requires that the individual is enrolled in the Federal Workforce Investment Act program and is receiving "Intensive" or "Training" services at the time the program begins. Attach verification of enrollment in WIA to this application.

<u>Vocational Rehabilitation Participant</u>: Requires that the individual be an active participant in a State Vocational Rehabilitation Program. Attach a copy of your Rehabilitation Plan to this application.

<u>Trade Readjustment Participant:</u> Requires that the individual was a member of a worker group certified by the US Department of Labor to meet the eligibility requirements of the Federal Trade Act. Generally, these are workers who have been laid off as a result of international trade. Attach verification from the State Agency notifying you of your eligibility for benefits under Trade Act.

<u>Tribal Scholarship Applicant</u>: Requires that the individual is an enrolled member of a Federally Recognized Native American tribe who has applied to their tribe for a current year scholarship or vocational training program.
