### General Scholarship Eligibility and Information

- Each scholarship applicant must complete a Free Application for Federal Student Aid (FAFSA) and apply for all available federal grants.
- The scholarship is intended to assist the student in meeting their remaining tuition and fee obligations; award amounts will be determined after all available grants have been finalized.
- Students will be notified of their scholarship award status. Acceptance of an individual scholarship award is an agreement to the terms and conditions of that award as well as all policies governing Arizona College scholarships.
- All scholarship recipients are expected to abide by the principles of academic integrity and the Arizona College Student Code of Conduct.
- Every student's financial award package is subject to review by the Financial Aid Office for compliance with federal aid regulations and the eligibility requirements for each scholarship program.
- A student's total grant, scholarship, and other gift aid may not exceed tuition, fees, room and board; if they do, the scholarship provided by Arizona College will be reduced accordingly.
- Arizona College reserves the right to adjust individual scholarship awards to account for adjustments to federal, state, and scholarship dollars.
- Scholarship recipients must have at least half-time enrollment.
- Renewable awards are contingent upon maintaining the satisfactory academic progress standards found in the Arizona College catalogs. The other specific renewal criteria for the specific scholarship must also be met.

## Specific Scholarship Requirements

Workforce Innovation & Opportunity Act Participant:

Requires that the individual is enrolled in the Federal Workforce Innovation & Opportunity Act program and is receiving "Intensive" or "Training" services at the time the program begins. Attach verification of enrollment in WIA to this application.

Vocational Rehabilitation Participant:

Requires that the individual be an active participant in a State Vocational Rehabilitation Program. Attach a copy of your Rehabilitation Plan to this application.

Tribal Scholarship Applicant:

Requires that the individual is an enrolled member of a Federally Recognized Native American tribe who has applied to their tribe for a current year scholarship or vocational training program. Attach verification from your tribe that you have a pending current year scholarship or vocational training application.

Salt River Pima Maricopa Indian Community Scholarship:

Requires that the individual is an enrolled member of the Salt River Pima Maricopa Indian Community who has applied to the SRPMIC Education department for a current year scholarship. Attach verification from SRPMIC-Education Department that you have a pending current year scholarship application.

Continuing Education Scholarship (AZC - Allied Health Career Advancement):

Student must be a graduate from an Allied Health program taken at Arizona College. Upon acceptance into the Arizona College of Nursing BSN program, graduates of an Arizona College Allied Health program will receive a scholarship equal to the amount of tuition paid at the time of this application, not to exceed the published tuition cost of the program at the time of enrollment. The scholarship will be an adjustment to each BSN semester tuition charges, calculated per credit, and is based on enrollment status (this scholarship is not subject to the Less than half time enrollment for the semester limitation).
